5. Application and **all required documents** must be **sent via one email** to your **local county Farm Bureau office by Thursday, February 10, 2022.** Do not send to the state office.
6. Students who hold a Farm Bureau membership in more than one county can only submit one application to a county Farm Bureau office within the state of Iowa.
