#### **Basic Qualifications**

To apply, a student must:

- 1. Have been a resident of Adair, Adams, Taylor or Union County, Iowa, for the past (3) three, calendar years, at a minimum. Note that leaving the county to attend a college or university does not constitute a change of residency for purposes of this scholarship.
- 2. Have had a 2.0 or better GPA in high school (<u>and</u> college if applicable).
- 3. Attend an accredited United States college or university for the 2022 2023 academic year, which requires a high school degree for entry.
- 4. Not be employed, live in the same household, or have a member of their immediate family (sibling, spouse, parent, grandparent) employed by Iowa State Savings Bank (Creston, IA), Ames National Corporation or their affiliates.
- 5. Notify the Trustee immediately if their college or university enrollment plans change from those identified on the application.

#### **Scholarship Amount and Coverage**

The WD Ray & Shirley Schafer-Ray Educational Trust will award at least (4) four scholarships with a maximum value of \$10,000.00 per scholarship.

Scholarships are awarded on a one-time basis. Applicants must request a <u>new</u> application to reapply each academic year.

#### How to Apply

An applicant's complete submission must contain:

- Completed 2022-2023 Scholarship Application
- □ Three (3) signed letters of recommendation
  - Letters of recommendation must be from:
    - A high school administrator/counselor/teacher, or
    - A College advisor/professor, or
    - A leader of a community organization
- □ A copy of the applicant's most recent high school or college transcript

All submissions must be complete. Incomplete submissions or those submitted in parts will be deemed incomplete and discarded upon receipt. Applicants should allow themselves adequate time to collect and complete all necessary documentation before <u>March 1, 2022</u> (the "deadline").

The Trustee will review each submission for completeness and provide a confirmation receipt to each applicant. It is the applicant's responsibility to be certain they receive the confirmation letter prior to the March 1st deadline. It is recommended that the applicant retains a copy of their completed application and proof of delivery at least until they receive the confirmation letter from the trustee.

#### Selection of Scholarship Recipients

The Trustee will review submissions as they are received, and the applicants selected as scholarship recipients will be notified by **April 15**<sup>th</sup>.

#### Payment of Scholarship Funds

The trustee will send the one-time scholarship award directly to the college or university after the trustee receives verification of enrollment at the recipient's chosen school.

Scholarships will be applied to the 2022-2023 academic year and divided equally between the fall and spring semesters. If the applicant does not enroll in the spring semester, the portion of the award attributable thereto shall be returned to the Trust.
